Corn, High Oleic Oil (contains one or more of the following: Canola or Safflower Oil, Salt, brown sugar, maltodextrin, garlic and onion powder, spices, lemon juice powder (corn syrup solids, lemon juice, and natural flavor), spice extractive, natural flavors, and silicon dioxide added to prevent caking.
